A History of Constitutional Carry in Texas A note from GOA Texas Director Rachel Malone

In 2013, I showed up at the Texas Capitol to tell the legislators to stop infringing on my rights and pass Constitutional Carry. I leaned a few things that year. First, very few legislators care about my rights. Second, nobody knew what "Constitutional Carry" meant. Third, me showing up by myself was never going to be enough to protect our gun rights.

Over the next few years, I worked with others around the state to promote the concept of Constitutional Carry – which means, simply, "if you can own it, you can carry it." If you can legally own a handgun, you should be able to carry it, open or concealed, without asking the government for a permission slip. We got the attention of Texan gun owners, filed bills, and brought hundreds of people to the Capitol to speak up for their rights. But it still wasn't enough.

Since 2013, the total number of states with Constitutional Carry (open or concealed, without a license) has gone from 4 to 17. Unfortunately, Texas is not among those states. In fact, Texas isn't even among the 31 states that will let you carry a handgun openly without a license.

This legislative session, with the Federal government vigorously threatening your gun rights, it's critical for Texas to stand strong. But once again, it will
