Where are gun rights priority bills?

The Texas legislative session hits its 60-day mark on March 12. Bill filing will end, and the House and Senate can begin considering bills on the floor – but only if the bills have moved through committees.

Bill Filing: So far, legislators have filed over 3,000 bills. We're tracking well over 100 gun-related bills so far – including 30 bills on GOA priority issues!

Committee Process: House and Senate leadership have appointed committee chairs and members, and the lists include multiple GOA-endorsed candidates. The process of sending bills to committees and scheduling committee hearings has begun. However, we've seen significant delays, partly from COVID- and weather-related issues.

Because **most bills die in committee**, we need your help to keep our priority bills moving!

We'll let you know when you can call committee chairs to ask for a hearing, and committee members to ask for a favorable vote. But things move quickly, and sometimes we need your help right away.



Why is Texas so far behind?

In the month of February, **Utah** passed Constitutional Carry, **Montana** passed a Constitutional Carry update, and **Indiana's** State House passed a Constitutional Carry bill that now moves to their State Senate.

Meanwhile in Texas, you can still go to jail for peacefully walking down the street carrying a holstered handgun if you don't have a permit.



It's time to get Constitutional Carry in Texas, so those who can legally possess a handgun can carry it, open or concealed – no permit required!
